MY HISTORY OF MOTIONS WHILE ON COUNCIL:

- **Recreation Centres** | This motion approved a new financial strategy that saved the development of four new Recreation Centres in Calgary. Three of these centres will be in the southeast - two of which are in Ward 12.
- **Public Art Review** | The result of this motion was a review of the Public Art funding models across North America, specifically, the concept of a tiered approach for the level of contributions.
- **Funding Options for SETWAY** | My notice of motion outlined alternative funding options for different stages of the southeast LRT. By passing this motion Council and Route Ahead recognized the need to explore various financial methods and these funds will be in addition to the \$137 million that was designated after my motion for **Green Trip Funding**.
- **Asset Management Strategy** | This proposal was intended to cut the red tape; making it easier for administrators to manage the vast inventory of city-owned

assets. This will give us an accessible database that allows the City to evaluate properties and determine whether each property is being used in the most efficient manner possible.

- **Sponsorship of LRT Stations** | The City of Calgary has a number of city owned assets such as LRT stations that can offer sponsorships to the private sector. These sponsorships will bring in extra revenue and provide resources for projects that may otherwise be delayed or go unfunded.
- **Honouring Calgary's Serving Soldiers** | Recognition of service and commitment from our Canadian soldiers continues to be a cause that is very dear to me. My nephew Cpl. Shane Keating was killed in action in Afghanistan in 2006. This motion directed Administration to allow a symbolic yellow ribbon on all City of Calgary owned vehicles to show gratitude and support for the efforts and lives that have been lost.
